Grant Status as of September 30, 2020

1. Beck School of Practical Nursing at Career Center of Southern Illinois acknowledges that the Certification and Agreement has been signed and returned to the United States Department of Education. No less than 50 percent of the funds will be used to provide emergency financial aid grants to students.
2. The total amount of funds received by the Beck School of Practical Nursing totals \$274,402.
3. The total amount of CARES funds distributed to students to date is \$137,201.01.
4. A total of 69 students are eligible for the emergency grant funds.
5. A total of 69 students were eligible for and have received a CARES emergency grant.
6. Eligible students were asked to complete a survey to determine their needs for an emergency grant. Eligible expenses could be related to housing costs, food, needed resources to complete coursework remotely, healthcare, and child care. A committee which included members from administration, student services, and financial aid met to determine how the funds would be distributed to students who had completed the surveys. Due to a high need for grant funds by all students, 50% of the emergency funds were divided equally among all students who were eligible and enrolled during the statewide quarantine. Grants were prorated for students who enrolled after the actual start date for a course. All students signed documentation of receipt of the funds at the time funds were distributed. A driver's license was required to ensure identity and no one other than the student was allowed to sign for the check.
7. Students received correspondence from the institution via their registered school email account.
8. Institutional Funds have been used to support to the additional costs of the in-person to remote learning. Examples are: chrome books for students, hotspots, additional technology for staff, and purchase of instructional resources used to supplement curriculum. Additional software for remote access and instruction. PPE and cleaning materials used specifically to meet safety guidelines for Covid-19.
